

PUBLIC ADMINISTRATION AND PUBLIC-SECTOR MANAGEMENT

Studying public administration means studying the functioning of public bodies, the development of public policies, the management of government finances and the principles of management and governance in order to improve the way all of these operate. The upheavals of the 1980s and 1990s, budget problems, citizens' new demands on government and the interest aroused by reforms carried out in certain countries have all made the modernisation of the public sector a necessity. Such a reform involves applying management concepts to the performance of the public services, without dogmatism and taking into account the specific features of public policy. It also entails reflecting on the desirable perimeters of public administration in a modern democracy, as well as on the distinction between the citizen or user (deprived of all choice) and the customer (free to choose). In their strategy-making, the public authorities must also take into account pressures which go beyond the need for a new social bond: the fact that purely 'local' decision-making no longer exists (owing to the spread of European, EC or international legislation), risk management, aptitude for dialogue and listening to others, need to anticipate and evaluate the repercussions of public policies on the community.

The programs proposed by French educational institutions focus on these aspects of government reform and benchmarking in order to bring students to question the nature of present changes in law and public administration. The study of management methods applied to the central administration or local governments, quality and human resources management are fully integrated into such programs, along with units concerning specific areas such as public health, education, environment and safety.

ÉCOLE NATIONALE D'ADMINISTRATION, STRASBOURG, http://www.ena.fr

Founded in 1945, ENA trains future senior officials in the French and foreign public service. The school offers several programs, aimed at young civil servants or students (limited possibilities of access for the latter, involved in the CIL, CIAP or CISAP, programs described below), and above all experienced civil servants, who are recruited through the French embassy network abroad.

Admissions requirements (certain programs may have particular requirements; see the detailed descriptions on the ENA website or that of the Centre for European Studies in Strasbourg, CEES); being a civil servant, other public employee or, less frequently, a student intending to pursue a civil-service career in his or her country of origin; having a higher-education diploma; writing and speaking French fluently; passing the entrance exams organised by ENA. Tuition is free but students are responsible for their living expenses. Candidates can request financial aid.

ENA programs for foreign students (for complete information, see the "International cycles" section on the ENA website):

· Long-Term International Cycle (CIL): 18 months in Strasbourg, general studies integrated into the initial training curriculum for French students; candidates should be under 35 years of age.

 Short-Term International Cycle (CIC): 9 months in Strasbourg, general studies, integrated into the upper-level further training cycle for French administrators; aimed above all at experienced high-level civil servants, mainly diplomats seeking assignments in France; candidates should (in principle) be under 30 years of age.

International Cycle in Public Administration (CIAP): 6-1/2 months in

Strasbourg, aimed at experienced civil servants (candidates should be at least 25 years of age), specialised in 3 sections: Public Administration and Institutions, Economics and Government Finance, International Relations.

 Some 30 Specialised Short Cycles in Public Administration (CIAP): 2 or 4 weeks of intensive further training carried out mainly in Paris, inclu-

ding several in English and Spanish.

Long European Studies Cycle (CEES), http://www.cees.Europe.fr/en/etudes/cyclelong.php: 7 months at the Centre for European Studies in Strasbourg, aimed at a varied public (high-ranking civil servants, elected officials, corporate managers), permits ongoing professional activity, aimed at citizens of European Union member or candidate countries. CIL students can complement their training in parallel with applied research leading to a Masters program in Public Administration (MAP); students who have successfully completed the CIC or CIAP (exam scores of at least 14/20) can apply for this Research Masters program.

European Masters in Governance and Administration (MEGA), set up in 2004, is open to young officials who are citizens of France, Germany and other European Union member or candidate countries; the diploma is granted jointly by the Universities of Potsdam and Paris 1; this is a bilingual French-German program.
